- --will categorize donors according to when they donated, last 5 years, 10 years, etc. and start looking for more donors.
 - --Working to finish the video with Allen Bertram. And, include a video on recruitment.
 - --Doing a monthly newsletter with a faculty spotlight, upcoming events & activities.
 - --AIHEC has not had a student conference since March, 2019. Planning for a conference this year.
