## Discussion on the following issues:

- Grievance Policy/Procedure. Concerned about the length of time to resolve individual issues.
- Founder's Mandates.
- Should be involved in the selection of Vice Presidents and department chairs with recommendation by the President.
- Currently no CFO. Need to be involved in the selection of a CFO.
- Need to ensure that an evaluation is done after the probationary period for new hires.
- By-laws: page 11, Officers of the Corporation should be the Trustees or Regents. Need to clarify the term.
- Check-signers should be done by resolution.
- Executive Secretary for the Board should not work under the staff. The Board will do the hiring for the Secretary. (Re-wording on page 7 to include this).
- Ensure there is no co-mingling of federal funds.
- Need policy to justify time to receive hazard pay/premium.
- Discussion on Board vacancies. Put ads on SGU Facebook page, SGU webpage, RST communications page, radio stations.
- There is one candidate for District 3. Have received student association election results.
- Recommendation for Grievance Process made by Richard Lunderman. .

- Discussion on the provost position which is not included in the organizational chart.
- Hiring and supervision of relatives. Suggested language: Employees are not allowed to hire nor supervise immediate family members/relatives.
- Recommend the Board serve as the Grievance Board.
- Need to develop a policy for "work from home" due to illness.
- Some organizations/institutions allow employees to cash in their annual/sick leave at the end of their contract.
