- Considered setting up an emergency scholars program. The emergency program will be for those students who have no other type of financial aid.
- Set up a "reach out to the freshmen students". Award a \$500 scholarship and in order to receive the next \$500 you must have passed 3 classes, etc. This will also give the students an opportunity to meet other students and socialize.
- Need more secondary counselors. State legislature is talking about funding for non-Indian students.
- Todd County closed down the schools when the temperature reached 20 below. Do we want to do something similar?
