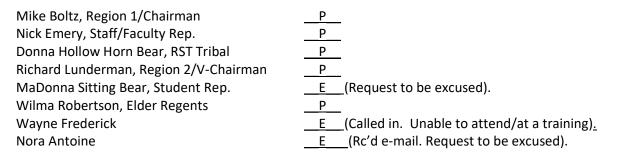
SINTE GLESKA UNIVERSITY BOARD OF REGENTS REGULAR MEETING JUNE 2, 2023

Motion by Nick Emery and seconded by Nora to appoint Mike Boltz, Richard Lunderman, Wilma Robertson, HR Director for the Rosebud Sioux Tribe and HR Director for REDCO to serve on this particular hearing. The Committee will be compensated \$250 per day plus mileage. Vote: 6/0/0, motion passed.

The administration is recommending the Board hear this grievance.
