- Poverty on our reservation must be addressed.
- Expand our bookstore to include other needs (i.e. clothing, etc.).

- Assist communities to develop a plan to set up convenience stores.
- Would like to increase staff/faculty salaries.
- Campus beautification.
- Upgrade our facility needs.
- Have outgrown the heritage center. Possibility is there to do a partnership with the Tribe to build a larger facility to meet the needs of the whole Tribe.
- Need more lighting on campus for security purposes.
- TLE filed a lawsuit against SGU due to the incident with the buffalo project. Very disturbing that they are disregarding our sovereignty. Attorneys recommend a settlement of \$50,000 and close up the case. Pechota will submit disclosures for the settlement.

- Need more scholarships for tribal and non-tribal members.
